Starting with a lecture by Professor Noboru Yamazaki on "What Disaster Prevention Education Aims for," and presentations by students from Otari Elementary School and Hakuba Junior High School, two schools that have been working on regional disaster prevention education, the event provided an opportunity for many residents to be reminded of the efforts being made to keep the memory of the disaster from fading.

Even though snow piles up on your driveway or properties, the public drive way is no place to put any object, including snow. Shoveling or plowing snow onto the road or the shoulder creates a hazard to other drivers and snow plow operators. What is bathing tax?



-Article 701 of the local Tax Act

The bathing tax is an earmarked tax that is used to Cover expenditures for environmental sanitation facilities; the protection and management facilities for the sources of mineral springs; maintenance of firefighting facilities; and promotion of the tourism.

Taxpayer -Article 141 of the Hakuba Tax Act Persons who took a bath in a mineral spring facility (Including hot and cold spring)

Non-taxpayer -Article 142 of the Hakuba Tax Act Bathing tax is not levied on the persons listed as follows.

- ① Children under 12 years old
- ② Users of non-profit mineral spring public bath facilities
- Students come for a school event
 Eq. School excursion until Senior High School)
- ④ Players, executive members or the press who come for an international contest which is organized by Hakuba Village; and is nominated by Hakuba Mayor.

Tax Amount -Article 143 of the Hakuba Tax Act

A day tripper: \$50 /person

A overnight guests: $\frac{150}{\text{person a night}}$


Snow-Control Housing Improvement Project / Net Zero Energy House

Snow-Control Housing Improvement Project

A subsidy will be provided for a part of the construction cost of snow-control housing to reduce the physical burden of clearing snow from the roofs of houses and to prevent accidents such as falling down.

1. Eligible snow-control construction

(Except for combined dwellings where the residential area is less than 1/2 of the total floor area)

Winter Tentative Water Bill

For customers who are unable to receive meter readings during the winter (December to March) due to snow (*Except for customers on an automated meter reading system.), water and sewer charges will be based on provisional water consumption from the January to April, and will be charged based on actual water consumption in the May after the winter.

Tentative water amounts will be mailed to eligible customers in early December.

The provisional water volume can be changed. If you require a change, please fill out the enclosed return postcard with your requested water volume setting and return it to the Water and Sewer Division by December 27(Thu). If no change is needed, the reply is not required.
