

Subsidy Hakuba Village Project to promote and support the replacement of energy-saving home appliances

Hakuba Village is promoting the replacement of household appliances with energy-saving appliances and eco-friendly cars in order to reduce household energy costs and support the lifestyles of village residents. Therefore, Hakuba Village will provide subsidies to villagers who replace their home appliances and cars with the following products, based on the subsidy grant outline.

- I. Grant Eligible Applicants (those who meet all of the following conditions)
- (I) A person who has a registered address in the Village. A person who lives in a house in the Village. (This house includes a house used in combination with a store, office, etc.)
- (2) A person who installs the energy saving appliances in his/her home, or whose applicant's address matches the owner's or user's address on the vehicle inspection certificate of the ecological car.
- 2. Eligible Products and Requirements
 The following qualifying products must be purchased between
 April 1, 2022 and January 20, 2023 and meet the requirements
 (eco-friendly cars may be leased for one year or longer).
- 3. Subsidy eligibility breakdown, subsidy rate, and subsidy limit



The 101st All-Japan Ski Championships Hakuba Special Jumping Competition was held on October 21 and 23. The normal hill competition was on the 21st and the large hill competition on the 23rd.

Hakuba village cash payment project for countermeasures against high oil prices and soaring prices

Hakuba Village will send application-related documents to grant recipients.(It's called push type)

Hakuba Village will implement a Cash Benefit project to provide

temporary and emergency assistance to villagers facing the effects of sharply rising oil prices and rising prices of commodities, in a simple and precise manner.

Please note that only those who meet the following requirements are eligible for this project.

In addition, the General Affairs Division plans to send an "application and claim form" for this project to those who are considered to be eligible by push type around the date of the start of acceptance of applications.

I. Eligible persons

The head of household must be registered in the Hakuba Village Basic Resident Registry as of September 30, 2022 (hereinafter referred to as the "Reference Date") and live in Hakuba Village as of the date of application. However, the following persons are not eligible

- •Households consisting only of dependents under the Income Tax Law •Households that have received temporary special benefits for Hakuba village resident tax exempt households •Households with total income of 3 million yen or more per household in FY2021
- 2. Benefit amount: 15,000 yen per household

- 3. Application period: Must arrive between Nov. 28, 2022 and Jan. 31, 2023 (postal stamps on Jan. 31 are valid).
- 4. How to apply: By filling out the designated application form.

5.Others

•The designated application forms will be sent to those who are considered to be eligible for the grant approximately by the start date of application. (Even if you do not receive an application form in the mail, you are eligible for the subsidy if you meet the left requirements, so please apply at the General Affairs Division counter.)

Upon receipt of an application, those who have been qualified will receive the benefits by bank transfer.

If you are eligible for benefits but do not apply by the deadline, you will be deemed to have declined to receive benefits.

Do you know that there is a program of property tax reductions for homes that have undergone seismic retrofitting, barrier-free retrofitting (for the elderly), and energy conservation (to prevent heat loss)?

As a general rule, applications must be submitted within three months of the completion of the renovation work.

There are regulations for the construction date, floor area, construction details, and occupant requirements for each of the houses for which the application is submitted. Beware of water pipe bursts and other water leakage accidents in winter

Another cold winter is coming soon. In winter, the number of accidents involving water leaks in houses due to freezing increases rapidly. From the water meter to the inside of your house, it is under your control. For your peace of mind, please prepare your water supply during the winter season.

Do you know where the water meter is installed?

Check the location of the meter in case of a leakage accident. Also, do not place any objects on top of the meter.

Freezing Prevention Measures You Can Take

- •Turn on the antifreezing electric, if you have.
- •Wrap the heat insulating material as well as blanket or fabric around the pipes and faucets, and then secure with tapes.
- Put the dry heat insulating material such as polystyrene which covered by the plastic bag into the box of meter and keeps inside warm. That is an advice of using the plastic bag because it can be easy to clean even if the polystyrene breaks and scatters in the box.

When the water pipe bursts

First, close the antifreeze water valve. Then apply first aid by wrapping a cloth or tape tightly around the ruptured part. Then apply for repair to an authorized plumber in Hakuba Village. If your meter bursts, please contact the Water Supply and Sewerage Division. Confirm the location of the water meter. Do not put any objects on the water meter, please.

Points to keep in mind during draining operations

If the antifreeze valve is

in adequately operated in the half-open position, water will continue to flow and may result in a leak. After this operation, be sure to check the water meter to see if the water has been shut off. If the water meter does not stop, the antifreeze valve may be damaged and should be repaired by the Hakuba Village authorized plumbers. Don't forget to drain water from water heaters

water from water heaters and toilet appliances. Even if you drain the water with an antifreeze valve, there will still be water in the pipes of the water heater and toilet. This may possibly damage the appliance, so please drain the water.

Winter Provisional Water Rates Will Begin!

(There will be no change for customers with automatic meter readings.)

OWater meters cannot be read during the winter months of Dec. through Mar., except for customers on automatic meter reading. For this reason, water and sewerage charges are billed based on the provisional water quantity (provisionally set water quantity) from the Jan. billing to the Apr. billing, and the settlement is made in the May billing.

OA notice will be sent in early Dec. to customers who are unable to get a meter reading to set the provisional water quantity. We have entered in that notice the same figures as last year, both in terms of provisional water quantity and bill amount.

The tentative water quantity and bill amount can be changed if requested by the customer. So if you wish to change, please fill out the return postcard with your desired water quantity setting and bill amount, and then return it to the Water and Sewer Division by Friday, Dec. 23, 2022. If you do not need to change anything, you do not need to return the postcard to us.

- *As a general rule, the quantity and bill amount of water cannot be changed in the middle of the above period.
- **However, if your actual usage is higher than the quantity you set, your May bill will be higher.
- *When you discontinue use, move, or change the user, please be sure to contact the Water and Sewerage Division for immediate settlement.
