Japan to allow e-scooter riding without a driver's license from July

E-scooter users will no longer require a driver's license from July, though people under 16 will be banned from riding the vehicles, placing e-scooters under a newly created legal category of "Specific Small Motorized Bicycles".

The new rules apply to scooters with a maximum speed of 20 km/h, and riders must comply with the same traffic rules as cyclists, including, in principle, not riding on sidewalks. Scooter riders are advised to wear helmets, although it is not mandatory.

E-scooters must have ...


Head lamp, Number plate, Light and Direction Indicator which satisfy the safety standards of the Road Transport Vehicle Law. Driving such a scooter on a road (footpath or roadway) without satisfying the regulations constitutes a violation of Article 62 (operation of improperly equipped vehicle) of the Road Traffic Law. Insurance

What's "Specific Small Motorized Bicycles"??

[SIZE] Up to 190 cm in length and up to 60 cm in width.
[POWER] 0.6kW or less, maximum speed 20km/h
The highest speed cannot be changed while driving.
[Tax Amount] 2,000 yen

As stipulated by the Road Transport Vehicle Law, a moped cannot be operated without automobile third-party liability insurance.

For those who has National Health Insurance Cards

From August 1, the color of National Health Insurance Card will change to "sky blue". In the upper right corner of the card, the expiration date will be printed as "July 31, 2024. The new insurance card will be mailed to each household around the end of July in a blue envelope. About My Number Insurance Card

This will be the last time that insurance cards will be issued, as each insurance card will be transferred to the My Number Card Insurance Card. If you do not have a My Number Card, it is recommend that you apply for it as soon as possible. Your Individual Number Card can be used as your health insurance card. SUBSIDIES AND GRANTS INFORMATION

Snow-Control Housing Improvement Project

A subsidy will be provided for a part of the construction cost of snow-control housing to reduce the physical burden of clearing snow from the roofs of houses and to prevent accidents such as falling down.

(Except for combined dwellings where the residential area is less than 1/2 of the total floor area)

Net Zero Energy House

To reduce CO2 emissions resulting from home use of electricity and gas, the government is promoting the spread of Net-Zero-Energy Housing (ZEH).

Hakuba Village will subsidize up to 300,000 yen per unit for "ZEH New Construction" or "ZEH renovation" that meet the following requirements, utilizing subsidy programs provided by the government and Nagano Prefecture.

- (1) Pellet stove must be a stove that uses pellets as fuel.
- (2) Hakuba Village and the dealer will sign an agreement (for 3 years) regarding the supply of Shinshu-grown pellets as fuel.






THE SURVEY OF THE CURRENT CONDITION OF BUILDING

Purpose of the survey

In order to accurately evaluate the current status of buildings, more appropriately manage the fixed asset taxation records, and ensure fairness in taxation, the village will conduct surveys to confirm the current status of buildings throughout the village beginning in 2023. This survey will be conducted by comparing aerial photographs with the village's fixed asset taxation records, and will mainly investigate buildings that have not been taxed and those that have already been knocked down but are still registered in the records.



What is buildings for property tax purposes?

Survey Period and Method

Two types of surveys will be conducted: a visual survey from a public road and an on-site inspection.

(1) Visual survey from public roads

Visual inspection from the public road to confirm that the current conditions of the building match the registration in the village's house taxation registry.

The property owner does not need to be in attendance, also the inspector will not come onto the property. The survey will be conducted during the fiscal year 2023.

(2) On-site inspection

This survey will be conducted when a more detailed survey is necessary, such as when the current conditions differ from those registered in the village's house tax registry as a result of a visual inspection from the public road. The property owner will be notified in advance, and a survey will be conducted in the owner's presence to confirm the structure, floor area, and finishing materials of the house. The survey is scheduled to be conducted in 2024 or later.

follows.

1. Exterior air separation...Roofed and enclosed on three or more sides by exterior walls.

- 2. Fixation to the land: The structure is fixed to the land (fixed to the foundation).
- 3. Usability...The property can be used for living, storage, preservation, or other purposes.

Accordingly, even garages, sheds, etc. are subject to property taxation if they meet conditions 1-3. There are no taxation or non-taxation standards based on the size of the floor area, whether or not an application for building permit is filed, or whether or not the property is registered.

Beware of Spoofing
The survey team members who conduct the survey must have a "Fixed Asset Valuation Assistant Certificate"
and a nameplate with their name and department on it.
If you notice anything suspicious, please check his/her identification. The surveyor will not ask you to do
anything other than the purpose of the survey.

SMART FARMING Agriculture of Hakuba

"Smart Agriculture" represents a new agricultural technology that utilizes robotics, information and communication technology (ICT) to achieve labor savings, precision, and high-quality production.

Agriculture is not only facing a nationwide shortage of farmers due to the decreasing and aging of the population, but also many tasks rely on human hands and skilled labor. In order to solve these issues, "smart agriculture" is expected to promote labor-saving and burden reduction in agricultural work, secure new farmers, and pass on farming techniques. Smart Agriculture" in Hakuba Village is still in its beginning stages, but we would like to introduce some examples in the village.





Remote-controlled water management system Automatic Water Plug (Field Water Management System)

Trial operations were done in 2021 and 2022 in rice paddies in the Fukasora area. This can remotely and automatically manage paddy filled water levels. This system reduces the burden of water management, but requires familiarity with the use of smartphones and other devices for operation.



Direct Sowing of Rice Paddy by Drone

In May 2023, JA, (Japan Agricultural corporation), and a drone company conducted a demonstration of direct seeding of rice paddies in the Fukasora area (approx. 1 Ha). By directly sowing specially coated seeds in paddy fields using a drone, heavy labor such as carrying seedlings and labor hours for planting rice are greatly reduced. Although germination rates and yields remain to be determined, it is to be hoped that this will help to solve the shortage of rice farmers.



Radio-Controlled Mower

Demonstrations were held in the limori district in July 2021 and in the Nohira district in June 2023 with the support of the manufacture. Compared to hand-held grass cutters and riding mowers, this can be operated by remote control. It can work on the ridge between rice paddies and slopes. Another benefit is that the operator is not affected by dust or vibrations.

Smart agriculture has the advantage of enabling the data collection of the skills, knowhow of skilled farmers and eliminating labor shortages, while at the current stage, the disadvantages include the cost of installing the machines and acquiring the knowledge necessary to handle the machines. In the future, as such machines become more widely used and the number of young farmers' increases, these disadvantages will gradually be resolved. In addition, it is expected that agricultural machinery will be replaced by electric power in the future from the perspective of global warming.
