

Illegal dumping and incineration are prohibited!!!

■ Why is incineration banned?

This activity damages for our health, spoils the landscape, pollutes the valuable environment, and produces harmful substances for example: dioxins. The grounds for saying that is the incineration temperature is low as around 200~300 degrees. Moreover you may cause for serious neighborhood's trouble about smokes, bad smells and so on.

■ What it will be?

Your behavior shall be punished by imprisonment and fine.

(Prohibition of Incineration) Article 16-2: No one shall incinerate waste except the following methods.

For an individual: 5 years or less or 10 million yen or less of the fine, or both imprisonment and fine. Article 25

For a company : 300 million yen or less. Article 32

■ Exception

The following cases are recognized as exception, although it is important to consider sufficiently for disturbing the surrounding resident, the size of the fire, the winds, the time, the necessary bare minimum of fire, be careful fire. Even your act is very carefully and safety, you will be a subject to administrative guidance, according to complain.

Regulations of Waste Management and Public Cleansing Law article 14

- The burning necessary for prevention of an accident, an emergency measure or restoration, Fire alarm drill, burn the straws for prevention of antifreeze and frost.
- Necessary for customs and religious festival.
- Unavoidable incineration for the primary industry, burn the straws on the field, the marginal grass.
- Bonfire, small quantity of the fallen leaves, the campfire.

■ Legally Incineration Plant

Regulations of Waste Management and Public Cleansing Law article 1-7

Standard Incinerator is as below:

- Can be incinerated at 800 degrees or more.
- Ventilating
- Inject waste into combustion chamber.

- A device for measuring the temperature of the combustion chamber.
- A burner for keeping 800 degrees or more.

Don't use incinerator which performance are not enough as above, and further to use the oil drums/metal barrel or enclose in blocks and iron plate or dig a hole in the ground, these are prohibition.

■ **Illegal dumping is prohibition**

Waste Management and Public Cleansing Law article 16: No person shall unnecessarily dump waste.

It prohibits illegal dumping, such as forests, roads, rivers and vacant land (including a self-owned land), indiscriminately throw away or bury the act is illegal.

Consider the toxic dioxins generated and living environmental impact, in fact, the marine environment is deteriorating.

The conscious of each of us able to hand over the beautiful village and comfortable living environment which the heritage to the future.

■ **Penalty for illegal dumping**

For an individual : 5 year in prison or 10 million or less of the fine or both.

For a company : 300 million or less.
