### Rabies prevention injection for pet dogs 2017

In Japan, owners are required to register a new pet dog at their local municipal office within 30 days of adoption. Once you register your dog, you will receive a license tag which should be attached to the dog's collar at all time. Besides, dogs are also required to be vaccinated for rabies once a year, between April 1 and June 30, according to the law.

### for discarding or transferring ownership of your light vehicle (Kei-jidosya) before the start of the new taxable year

In Japan, Light Vehicle Tax (Kei-jidosya-zei) is levied on car owners on a yearly basis, based on the registration record on April 1 of every year. In other words, the owners are required to pay the annual tax for their kei-cars discarding or selling on or after April 1. Please complete necessary procedures ASAP by March 31 to avoid extra expenses for your own interests.
