Every year in late March, it comes to a peak season of demanding for a car inspection and registration/ deregistration for vehicles.

For a renewal inspection, it can undergo one month before the term of validity ends. Please complete the required procedures as early as possible to avoid the busy period in late March.

Moreover, the owner of a taxed light vehicle (kei-car) as registered with the Transport Bureau on Apr 1 will be responsible for paying the lump sum vehicle tax on an annual basis. If you are planning to sell, to transfer ownership of or to scrap your kei-car, please make sure all the procedures are to be completed by Apr 1; Otherwise, you have to take up the responsibility in paying the Light Vehicle Tax of FY2018.

Please make a good plan to ensure you can make the deadlines.

Proper formalities before moving out of Hakuba at village office

When moving out of Hakuba to another municipality or when moving abroad, filing a move-out notification at Resident Division of Hakuba Village Office in advance is necessary. A move-out notification can be submitted within the two weeks before your scheduled move-out day.

Please note that the office is closed on weekends and public holidays. Make sure you or your foreign employees have made a good plan which allows enough time for completing all the required procedures before leaving Hakuba. Express service or move-out declaration via phone call is unavailable on all occasions.

> Moving to another municipality:

A move-out certificate will be issued immediately after one has reported his/her moving to the village office. Please be aware that a new address cannot be registered at the other municipality without the certificate. (Note: New address is needed when you submit the move-out notification)

➤ Moving abroad:

Submission of move-out notification is necessary even if you have a plan to come back with a re-entry permit. Especially for those who have joined the National Health insurance Scheme, you have to pay the insurance premium for the period that you are out of Japan if you leave without filing a move-out notification properly.

~TAX REFORM ~ <Spousal Tax Deduction> <Special Spousal Tax Deduction>

In an effort to promote women's greater participation in the workforce, Japanese government has raised the income limit for spousal tax deduction, from up to 1.1 million yen to 1.55 million yen (Residence Tax); 1.03 million yen to 1.5 million yen (Income Tax). The influences will be reflected on Resident Tax of 2019 and Income Tax of 2018.

Tax Deduction for "RESIDENTS"

In general, foreigners who have lived in Japan for more than one year are considered "RESIDENTS" under Japanese Tax Law. According to the law, foreign "RESIDENTS" have the obligation to pay different kind of taxes when compare to a "non-residents", but at the same time have the right to claim for a tax deduction.

Spousal Tax Deduction & Special Spousal Tax Deduction

A married couple can claim a (special) spousal tax deduction for his/her dependent spouse. However, the amount of deduction varies depending on the annual income of the dependent spouse.

How it works in Residence Tax

Residence Tax = per capital portion + income-based portion

The tax is levied on the residents who have an address in Japan on January 1 of the current year. A supporting spouse may enjoy a tax deduction for the "income-based portion". The table below shows a general image of the calculation method.
