Hakuba Village is consent Ministry the of the to Environment's national movement "COOL CHOICE". And as part of this year's project to curb carbon dioxide emissions, will be holding the "Hakuba EV Sharing" event, an electric vehicle sharing service, for the fourth consecutive year.

This is a free car sharing service available to Hakuba Village residents and businesses in Hakuba Village (driver's license that issued by Japan required).


This time, the vehicle is a single-seater ultra-compact EV COMS TOYOTA. It is an easy to handle vehicle that can be easily transported to the post office, bank, cafe, etc. in the village, and can be parked in a small space.

The term of use is one week. Take this opportunity experience the comfort of driving and operating an electric vehicle, please.

Now let's talk about lending. Hakuba Village residents can use the service once per person, and Hakuba Village businesses can use it once per company.

The event runs from Tuesday, August 10 Monday, November 1. You can rent a car on Tuesday and return it on Monday of the following week for one week.

Make a reservation at least four days before the date of use. For reservations, please



call 0261-72-5000 Hakuba Village Office and tell the operator EV sharing event. You will be connected to the general information desk, which will take your reservation.

The Hakuba Village website says that you should read the PDF Terms of Use and PDF Agreement in advance. However, this PDF file is not automatically translated. Therefore, we have prepared an English translation in the general Information of Hakuba Village office.

Now that the reservation was made, let's talk about the day of use. You can pick up your car at the Gas station, Shinko Sekiyu Hakuba Service Station during business hours from 9:00 am to 5:30 pm. This service station will not keep your car for the duration of the lending period.

The basic operation of the COMS, how to drive it, and precautions are posted on the website, but since this is also a PDF and cannot be automatically translated, it should be available at the Hakuba Village Office General Information. Instructions will also be available at the Gas station: Hakuba Service Station of Shinko Sekiyu.

The COMS runs on average about 57 kilometers on a full charge. So, for driving in Hakuba Village, drivers don't have to worry about charging locations, since the Hakuba Electric Vehicle Association has

already confirmed and made public charging locations. The charging location is available on the Hakuba Village Office website, but this is also a PDF file, so there is no automatic translation function. It will be available at the Hakuba Village Office

General Information.

Charging should be done with an ordinary charger for electric vehicles and a 200-volt outlet for electric vehicles. A full charge takes 6 hours.

During the month of August, the renter is supposed to pay the charging fee. However, from September, the Hakuba Village Office will hold the charging fee at designated charging locations. When to charge, please contact in advance the places that are helping you to charge.

To prevent COVID19 infection, disinfect the interior of the car (doorknobs, steering wheel, switches, and seats) when returning the car.

Please wash the car and return it. You cannot use a car wash machine. A discount car wash service is available at the Gas station: Hakuba Service Station of Shinko Sekiyu.

Application for vaccine certificates begin

Japan began accepting applications at municipal offices across the country for vaccine certificates, it's called Vaccine Passport, for people traveling abroad. Those who present a certificate that shows they have been vaccinated against COVID-19 will be able to receive preferential treatment, such as an exemption or relaxation of waiting times and virus tests upon entry in some countries on July 26, 2021.

The preferential treatment is available in In Italy, Austria, Sri Lanka, Slovak, Saint Christopher and Nevis, Saint Vincent, Thailand

Questionnaire survey and workshop for the revision of the Hakuba Village Community Development Master Plan

Have you ever heard of a system called "Furusato Nozei :hometown Tax Payment". Many people are born in their hometowns in the countryside and grow up receiving medical care, education, and various other services from the local government, but eventually move to the city for higher education or employment and pay taxes there.

As a result, the local government in the city receives tax revenue, but local government in hometown where they were born and raised does not receive any tax revenue. This is why the Furusato Tax Payment System was created after much discussion and deliberation, starting with the question, "Even if you live in the city now, shouldn't there be a system

that allows you to pay taxes, even if only a small amount, to "hometown" that nurtured you? The word "tax payment" is attached to the word "hometown. In reality, it is a "donation" to a prefecture, city, town or village. In general, if you donate to a local government, you can deduct part of the donation amount from your income tax and inhabitant tax by filing a tax return. However, with Furusato tax payment, in principle, the entire amount of the donation is deductible except for the 2,000 yen you have to pay. Please note that there are certain limits to the amount of donations that can be fully deducted, depending on your income and family structure.

The hometown tax payment system was established as a way to contribute to the hometown where you were born and raised, and to allow you to choose the local government you want to support. You can pay hometown tax to any municipality, not only to the one you were born in, so please choose the municipality you want to support after reading each municipality's policy on hometown

This is a request for garbage disposal.

We would like to express our deepest gratitude to all of you for your daily cooperation in sorting and reducing garbage.

Recently, there have been some cases of incorrect disposal of combustible bulky waste and metal waste.

Case 1 Bedding as the burnable bulky waste

The futon was not cut into the designated size, but was left in a large size and placed in a burnable garbage bag. If large items such as bedding are not cut to the specified size, it can cause damage to

the incineration facility and the transport vehicle. Therefore, we would like to ask for your cooperation in not doing so. When disposing of bedding in burnable garbage, please cut it into pieces less than 50 cm square.

*A large amount of bedding from lodging facilities is business-related waste.

Therefore, please outsource the disposal to a company with a waste transportation permit.

Case 2 A plastic container for clothes as the burnable bulky waste

The plastic container for clothing was left in its original form in a burnable

garbage bag. Large pieces may damage incineration facilities, so please cut them into pieces less than 5 cm thick before placing them in burnable garbage bags.

Case 1 LP gas cylinder as the metal waste

A household LP gas cylinder was cut and placed in a metal trash bag. Do not cut off the gas cylinder, as this may result in an explosion or other danger. When you no longer need LP gas cylinders, ask your dealer to take them back.

If you fail to pay your village tax, you will be charged a high rate of delinquency.

If you miss the deadline for payment, you will be charged a high rate of late fees in addition to the original tax amount.

The purpose of the delinquency charge is to maintain fairness in the burden between those who pay their taxes on time and those who fail to pay on time, and to prevent the occurrence of delinquency.

• Legal basis for delinquency charges Delinquent fees will be collected in accordance with the Local Tax Law and Hakuba Village Tax Regulations.

In principle, the amount of the delinquency charge will accrue from the day after the due date. The amount is calculated by multiplying the number of days from the day after the due date to the day of payment by the rate of 14.6% per year, except for the first month, when the rate is 7.3% per year.

• Establishment of a special standard rate for delinquency charges.

In light of the social situation where interest rates continue to be low, the percentage of delinquent payments was revised for the tax year 2013 and 2020. The following is a list of the percentage of delinquency charges to be calculated based on these special provisions and the changes.

• How to calculate delinquency charges.

The delinquency fee is calculated as

follows.

In the case that the tax due date is May 25, 2020 and 98,000 yen is paid on May 31, 2021.

(a) 2.6% per annum for the period from May 26, 2020 to June 25, 2020, the first month of this period.

 $$98,000 \times 2.6\% \times 31d/s \div 365d/s = $216 (Round down less than 1 yen)$

(b) 8.9% per annum for the period from June 26, 2020 to December 31, 2020

 $$98,000 \times 8.9\% \times 189d/s \div 365d/s = $4,516 (Round down less than 1 yen)$

(c) 8.8% per annum for the period from January 1, 2021 to May 31, 2021

 $$98,000 \times 8.8\% \times 151d/s \div 365d/s = $3,567 (Round down less than 1 yen)$

The total of (a), (b), and (c) is 8, 299 yen. Since amounts less than 100 yen are rounded down, the amount of the delinquency charge is 8,200 yen.

*If the tax amount is less than 2,000 yen, there is no delinquency charge.

* If the delinquent amount is less than 1,000 yen, all such amounts shall be rounded down. In other words, there will be no overdue payment.

*Fractions of less than 100 yen in arrears will be rounded down.

• Delinquent payments are also subject to penalty for delinquency. Please be sure to check the notice of finalized overdue payment as it is sent to those who have overdue payment.

A deferment system is available for those who are temporarily unable to pay by the due date due to unavoidable reasons such as disaster, illness, or business mismanagement due to the effects of COVID 19. If you are having difficulty paying your taxes in one lump sum, please consult with your tax advisor. Please consult with us by phone first.
