

Distribution of Hakuba Village Premium Gift Voucher

The effects of COVID-19 and rising prices are expected to be prolonged and worsened.

Therefore, in order to support the local economy and the lives of residents, Hakuba Village will implement the "Hakuba Village Premium Gift Voucher" project.

The gift voucher consists of 12 gift certificates (12,000 yen worth) with a face value of 1,000 yen. Hakuba Village will distribute one book for each villager free of charge.

- ○About the eligible person to be distributed
- ◆Eligible person: Must have a

registered address in Hakuba Village as of the end of June, 2022.

- Quantity of distribute: One book for each villager. Another book will be distributed to those who are 75 years old or older or who belong to a household receiving welfare benefits.
- Notification: A exchange ticket by postcard will be mailed to the recipients in mid-July from the Hakuba Village Office.
- ODistribution Methods
- ◆Distribution period: Wed. July 20, 2022 - Fri. Aug. 19, 2022 (excluding Sat., Sun. and National Holidays)
- ◆Distribution Time: 9:00 a.m. 5:00 p.m. (Wed. during the distribution period until 8 p.m.)
- ◆Distribution Place: Tourism Division counter and General Information of Hakuba Village Office

- Distribution Methods: Gift voucher books will be distributed free of charge in exchange for the postcard ticket mailed by the Hakuba Village Office.
- OAbout Exchange procedure
- Only you or your family members can exchange the gift voucher book. You will be asked to present documents to verify your identity. (Residence card, My number card, etc.)
- ◆The postcard mailed from Hakuba Village is an "Exchange Ticket" required to change the gift voucher. Please be sure to bring it to the exchange procedure.
- ◆Postcards mailed from Hakuba Village will not be reissued.

■ Temporary benefits for households exempt from residence tax.

This is a project to provide 100,000 yen per household to households exempt from residence tax in order to support the lives of people in need due to the effects of COVID-19 infection.



Hakuba Village Fire Brigade (Shobo-dan) Pump Operation Tournament and trumpet blowing Tournament on Sunday, June 5. ■ Eligible household

(1) Households exempt from per capita levy of residence tax in 2022

Households belonging to those who are registered as residents in Hakuba Village as of June 1, 2022, and are exempt from the resident tax per capita levy in 2022.

(2) Households that are exempt from the per capita levy of residence tax in 2021.

Households belonging to those who are registered as residents in Hakuba Village as of December 10, 2021, and are exempt from the resident tax per capita levy in 2021.

(3) Those whose household budget has dropped down suddenly.

For households other than those exempt from residence

tax, the household budget (income) suddenly dropped down from January 2022 due to the influence of COVID-19 infection, and in 2022, all members of the same household are almost exempt from residence tax. You must be registered as a resident in Japan as of December 10, 2021.

- ※Households that have already received extra special benefits will not receive this payment. (Including households received outside of Hakuba Village)
- *Households consisting solely of dependents of persons who are subject to per capita levy resident taxation regardless of (1), (2), and (3) are not eligible for benefits.

- A. You can estimate your national health insurance tax. If you would like to try it, please inquire after finding out the name of the health insurance participant, his/her income in the previous year, and the month when he/she started enrolling in the program.
- Q. I have enrolled in National Health Insurance. When will I receive my tax notice?
- A. You will receive it in the month

The project is designed to support young people who are responsible for the development of Hakuba Village's core industry, tourism, to make a Uturn and live in Hakuba Village. After graduating from Hakuba High School, students who receive a scholarship loan to go on to higher education, such as university, and then find employment at a business in Hakuba Vilage, will be subsidized to return the scholarship money.

OPeriod of subsidies:

Five years from the start of repayment of the scholarship; however if the registration is on or after the start date of repayment, the five-year period begins in April of the grant application year or the month of employment, whichever is later.

- **OEligibility Requirements:**
- Those who have received a scholarship loan to study at a university or other institution.
- Those who have a place of business in Hakuba Village and still have a regular employment contract with a company related to tourism and are working there.
- Those who have an address in Hakuba Village in the year of application.
- 4. Those who are 29years old or younger as of the end of the year of application.
- 5. Those who are not in arrears in the return of scholarship funds.
- 6. Those who are not in arrears with their village taxes.

- Q. I joined company social insurance, but I received a bill for National Health Insurance tax, why?
- A. Did you complete the withdrawal procedure for National Health Insurance at the Resident Division?
- Q. What happens to my tax amount when I join or withdraw from National Health Insurance?

- A. The Taxation Division will recalculate the tax amount.
 - Enrollment: The calculation is based on the period from the month of enrollment in National Health Insurance to March.
 - Withdrawal: The calculation is based on the period up to the month prior to the month in which you withdraw your National Health Insurance.

- Q. Who is eligible for 'special collection: 特 別徴収:Tokubetsu Choshu' deducted from pensions?
- A. The following four categories are eligible.
- ① All household members, including the head of household, who are covered by national health insurance are between 65 and 75 years of age.
- 2 Those who have an old-age pension

benefit of at least ¥180,000 per year.

- The head of the household is subject to special collection of long-term care insurance
- The sum of the National Health insurance premiums is less than one-half of the pension benefit (the annual amount of the basic old-age pension benefit divided

In addition, from October 1, 2022, those with an income above a certain level will pay 20% of medical expenses over the counter of medical institutes.

The burden ratio is determined on a household basis based on the insured person's taxable income, income amount and household taxation status in 2021.

- ■Criteria for paying 20% of the cost
- •The amount of the tax base on the resident tax notice is "more than 280,000 yen" and "the total income of pension income plus other income is more than 2 million yen".
- ·Pension income does not include survivor(:遺族年金) and disability pensions(:障害者年金).
- ·If there are two or more insured persons in same household, the total income of the pension plus other income is at least 3.2 million.
- •The criteria for 30% contribution remain unchanged.

Your insurance cards will be renewed from August 1,2022.

○Insured of the Advanced Elderly who are 75 years of age or older.

In FY2022, there will be a review of the burden ratio beginning October 1, 2022. Therefore, insurance cards will be sent twice: at the end of July for renewal as follow, ① and at the end of September for review as below 2.

Hakuba Village will mail an insurance card to each person twice in a yellow (: The Nagano Prefecture wide-area Federation of Medical Care for the Advance Elderly) printed on it, so please be sure to open it. If you have a Amount Applicable for the previous year, Hakuba Village will mail it together with change in your income.

However, those born on the 1st of the month will be sent in the middle of the previous month.

The renewal will take place from August 1. The beneficiary card will be the same colour as before, light green, and will be mailed to the relevant person from Hakuba Village office by late July.
